Subject: Ordinance # 02-12 INTOXICATING BEVERAGES/ILLEGAL SUBSTANCES

Due to the high quantity of alcohol being consumed at our County Facilities we are providing you with a copy of the Ordinance # 02-12, Intoxicating Beverages/Illegal Substances for you and your players, which is found in the Lee County Parks & Recreation Ranger Ordinance Booklet. You, as a team coach/manager/representative, will be responsible for providing your participants with a copy of the ordinance. The Lee County Sheriff's Department, Lee County Parks & Recreation Rangers and County Staff, League Representatives and Umpires will be enforcing this Ordinance # 02-12.

Ordinance # 02-12

SECTION 17.0 INTOXICATING BEVERAGES/ILLEGAL SUBSTANCES

GENERAL PROHIBITION.

Except as herein provided, no person shall possess, consume, use, sell or distribute alcoholic or intoxicating beverages, or illegal substances in any park. No person shall enter or remain in any park under the influence of alcohol, other intoxicants, or illegal substances.

Schedule of fines for violation of Lee County Ordinance # 02-12

In addition to the penalties listed above the following offenses will apply:

1st offense – manager & player gone for two games & forfeit game playing.

2nd offense – player gone for the season, manager gone for two games & forfeit game playing.

3rd offense – player gone for the year & forfeit game playing.

If the alcohol issue isn't solved during the season, Parks & Recreation will then have to charge the league to pay for a deputy to be scheduled at the facility. In return, your entry fees may be affected.

SECTION 17.0 INTOXICATING BEVERAGES/ILLEGAL SUBSTANCES

GENERAL PROHIBITION.
